Without touching the merits of the case and in order to enable the applicant to approach the concerned Court for pre-arrest bail, protective bail is granted to the applicant/accused for a period of four (04) days from today subject to his furnishing solvent surety in the sum of Rs.25,000/- (Rupees twenty five thousand) and P.R Bond in the like amount to the satisfaction of Additional Registrar of this Court.

The applicant/accused is directed to surrender before the trial Court within aforesaid period. Applicant is further directed to join the investigation forthwith.

This order shall cease to have its` effect on expiry of four (04) days from today i.e. on 29.05.2021 or on the applicant`s surrendering himself before the concerned Court, whichever is earlier.
