This Criminal Jail Appeal has been filed by appellant Ayoob through the Superintendent, Central Prison, Hyderabad against the judgment passed by learned Additional Sessions Judge-I/Mode Criminal Trial Court-I, Hyderabad, vide its judgment dated 19.03.2021, whereby appellant has been convicted and sentenced as under;

1.	302(b) PPC	Accused Ayoob Qureshi is sentenced to death, with order that he be hanged by neck till his death, for committing murder of deceased Mst. Samina. The accused Ayoob Qureshi is also directed to pay an amount of Rs.1,00,000/=(Rupees one lac) as compensation to her legal heirs as provided U/s 544-A Cr.P.C. In case of his failure to pay the compensation amount, the accused shall further undergo S.I for six months. The amount of compensation if recovered, the same shall be disbursed amongst the legal heirs of deceased Samina.
2.	302(b) PPC	Accused Ayoob Qureshi is sentenced to death, with order that he be hanged by neck till his death, for committing murder of deceased Mst. Saima. The accused Ayoob Qureshi is also directed to pay an amount of Rs.1,00,000/=(Rupees one Lac) as compensation to her legal heirs as provided U/s 544-A Cr.P.C. In case of his failure to pay the compensation amount. The accused shall further undergo S.I for six months the amount of compensation if recovered, the same shall be disbursed amongst the legal heirs of deceased Saima.
