Through the instant constitutional petition, the petitioners Mst. Shama and Farman Ali have prayed for the following reliefs:-

- a) That this Honourable Court may be pleased to direct the respondents No.4 and 5 not to harass the petitioners on the instance of the respondents No.6 to 11 and restrain the respondents No.4 and 5 not to lodge any false FIR against the petitioners No.1 and 2 and family members of petitioner No.2.
- b) That this Honourable Court may be pleased to direct the respondents No.2 to 5 to provide legal protection to the petitioners and the family members of petitioner No.2.
- c) That this Honourable Court may be pleased to quash the proceedings of such FIR if any registered against the petitioners and found false after the satisfaction of this Honourable Court.
- d) May be pleased to grant any other relief which the Honourable Court deems fit and proper in view of the above fact for protection of petitioners and in the interest of justice.”

Notices were issued against the respondents as well as A.A.G. Comments are filed by respondent No.5-SHO Police Station GOR Hyderabad, in which allegations leveled by the petitioners against the police officials have been denied. Learned Advocate for petitioners submits that petitioner No.1-Mst.Shama has contracted marriage with petitioner No.2 namely Farman Ali against the wishes of her parents. Copies of Affidavit of Freewill and Nikahnama have been annexed alongwith petition. Counsel for petitioners further submits that after such unceremonial marriage, the parents of the petitioner No.1 have approached to the SHO P.S GOR Hyderabad, who causes harassment to the petitioners. Today, the SHO Muhammad Ali Shah of P.S GOR Hyderabad is present and denies the allegations of the petitioners and further states that he is bound to discharge his duties according to law. Learned A.A.G also undertakes that the official respondents shall act strictly according to law.

In view of the comments filed by the official respondents as well as undertaking given by the learned A.A.G, the Counsel for the petitioners expresses his satisfaction and does not press the instant constitutional petition more, which is accordingly disposed of.
