4. Through instant criminal bail application, the applicant/accused seeks protective bail in crime No.56/2008, registered at Police Station Badeh, District Larkana, under Sections 302, 364, 353, 337-H(2), 148, 149, PPC.

It is, inter alia, contended by the learned Counsel for the applicant that the applicant is innocent and has falsely been implicated in the case. He further submits that the learned trial Court has already acquitted co-accused Ghulam Rasool and Ali Muhammad Sargani vide judgment dated 09.3.2015 and co-accused Sikandar Ali and Muhammad Ishaque vide order dated 12.5.2015. The learned Counsel further submits that the applicant/accused had, much earlier before the registration of this case, shifted to Balochistan and he had no knowledge about registration of the case against him and when he came back few days ago, the fact of lodging F.I.R against him came to his knowledge. Learned Counsel also submits that the applicant is ready to surrender before the trial Court alongwith application under Section 498, Cr.P.C, but he apprehends his arrest before reaching the Court of Sessions Judge, Larkana, as warrants are issued against him and for that he needs protection.

Without touching merits and demerits of the case, the applicant is admitted to protective bail for seven (07) days with effect from 16.11.2015 upto 22.11.2015 (both days are inclusive) subject to furnishing solvent surety in the sum of Rs.100,000/- and P.R bond in the like amount to the satisfaction of Additional Registrar of this Court. This order shall however cease to have its effect on 22.11.2015, after Court hours, or on any date when the applicant/accused surrenders before the Court concerned, whichever is earlier. Meanwhile, the warrants, if issued against the applicant, shall remain suspended.
