- 4. Through instant application, applicants Imdad Ali and others seek protective bail in Crime No.59/2014, of P.S Bakrani, under Sections 302, 114, 148, 149, 34 P.P.C.

Learned counsel for the applicants inter-alia, contends that applicants have been booked by the complainant in aforesaid crime with malafide intention and ulterior motive; in-fact incident is un-seen, but complainant in connivance of police has assigned the role to the applicants; there are general allegations against all the applicants, whereas role of instigation is assigned to applicant Imdad Ali; applicants intend to surrender before Sessions Court, Larkana, but the police has cordon-off the main roads leading towards that Court, therefore, they could not be able to surrender.

Without prejudice to merits of case of either party, the applicants are granted protective bail for four days commencing from today subject to furnishing solvent surety in the sum of Rs.100,000/- (One hundred thousands) each and P.R bonds in the like amount to the satisfaction of Additional Registrar of this Court, with directions to applicants that during this stipulated period they shall join the investigation and if they fail to join the investigation the concerned Sessions Judge shall also consider that aspect while deciding the pre-arrest bail application. Needless, to mention here that operation of this Order shall cease to have effect on expiry of four days from today, or on the day when the applicants surrender before the concerned

Court, whichever is earlier. It is made clear that, if the applicants fail to appear before concerned Court, surety furnished before this Court shall stand forfeited.
