Through instant constitution petition, petitioner Muhammad Umar has prayed for the following relief(s):-

- (a) That, this Honourable Court may be pleased to direct the respondent No.11 to conduct the fair inquiry into the matter and submit such report before this Honourable Court, and thereafter if respondents found involved in above illegal act than action according to law may be initiated.
- (b) To direct the respondent No.1 to 3 not to harass the petitioner on behalf of respondent No.4 without any legal justification.
- (c) To direct the respondent No.11 to provide protection to the petitioner and his family members and restrained the respondent No.1 to 3, and his subordinates not to act in violation of law.

Notices were issued against respondents as well as Addl. A.G. comments have been filed by respondents NO.4 to 10. In the comments filed by SHO Police Station Gaji Khuhawar it is stated that on 10.3.2014 complainant Ali Dost Khoso got registered a case bearing Crime No.7/2014 at Police Station, Gaji Khuhawar for offence under section 365/B, 457, 148, 149, PPC against petitioner Ghulam Qadir and his sons. SHO Police Station, Warrah has submitted that matter does not pertain to Police Station Warah.

It may be mentioned here that respondent NO.4 had filed Constitution Petition No.257/2014 against SHO Police Station Gaji Khuhawar and others. It was ordered vide orders dated 15.12.2014 to the respondents, to provide full

protection to all the parties as and when required by them and no harassment shall be caused to the parties involved in the case on any pretext.

The petitioner mainly seeks in this petition that respondents NO.1 to 3 are causing him harassment. It is ordered that all the official respondents shall provide protection to the petitioner as provided in law and they would not indulge in any activity contrary to law. Learned counsel for the petitioner has further submitted that private respondents have burnt the houses of the petitioner. It is ordered that petitioner would be at liberty to approach the concerned SHO for registration of F.I.R. In case of failure, he may approach learned Sessions Judge/Ex. Officio Justice of Peace concerned for directions of FIR in case a cognizable offence is made out. SHO/Sessions Judge/Ex. Officio Justice of Peace will act strictly in accordance with law.

With the above observations, this petition stands disposed of.
