This is an application for return of the surety. It appears that interim pre-arrest bail was granted to petitioner Shakeel Ahmed Mangi by this Court vide order dated 22-03-2018 in the sum of Rs.1 Million and P.R. bond in the like amount to the satisfaction of the Additional Registrar of this Court. Thereafter, surety was furnished by applicant **Ghulam Hussain** by depositing original Solvency Certificate No.11 dated 20-03-2018 issued by Mukhtiarkar (Revenue), Taluka Shikarpur and it was accepted. It appears that this petition was disposed of by this Court vide order dated 10-03-2021 by confirming the interim pre-arrest bail earlier granted to the petitioner subject to depositing entire amount equivalent to his individual liability mentioned in the Reference i.e. Rs.10,126,408/- through pay order. Thereafter, on approach of the petitioner, said order was set aside by the Hon'ble Supreme Court vide order dated 14-04-2021 and petitioner was admitted to interim pre-arrest bail subject to furnishing bond of Rs.5,00,000/- with one surety in the like amount to the satisfaction of Deputy Registrar (Judicial) of Sukkur Bench. In compliance of that order, one Ghulam Murtaza Aamir furnished surety by depositing photocopy of Solvency Certificate No.04 dated 24-04-2021 (original in another petition) and it was also accepted.

Subsequently, vide order dated 20-10-2021, this petition was

converted into protective bail against the surety already furnished by the

petitioner with direction to surrender before the trial Court within ten (10)

days. Special Prosecutor NAB submits that the petitioner has surrendered

before the trial Court in the aforesaid period. Copy of the order dated

29-10-2021 is also enclosed along with the application.

In the view of above, Special Prosecutor NAB has recorded no

objection for return of surety. Accordingly, this application for return of first

surety is allowed. Office is directed to return the original Solvency

Certificate to the surety after proper identification and verification as

per rules. Let the copy of this order be sent to the Mukhtiarkar concerned.
