Learned counsel for respondent No.6 denies such allegation and submits that the report furnished by ACE besides being false is also dubious whereas its signatory has denied the signatures on such report, however, requests for time to file a statement along with annexures to this effect. It has been submitted that purported report has no bearing on the merits of instant case, whereas, learned single Judge has rightly rejected the plaint under Order VII Rule 11, CPC.

Learned counsel for appellant submits that there has been subsequent development with regard to the subject land and has referred statement dated 05.11.2019 filed in HCA along with report of Anti-Corruption, according to which the subject land, i.e. Naiclass No.105, Deh Thomang, Tapo Gujro, Sector 50, Scheme No.33, Karachi, was not in favour of village nor the villagers have given power of attorney to respondent No.6. Learned counsel for respondent No.6 denies such allegation and submits that the purported report furnished by ACE besides being false is also dubious whereas the signatory has denied the signatures on such report whereafter FIR has been registered against the appellant, who is presently behind the bar in such FIR, however, requests for time to file a statement along with annexures to this effect. It has, however, been contended that the report of ACE will not support the case of the appellant in the instant case as the appellant was required to establish a prima facie case with regard to his entitlement over the subject land. This aspect of the case will be examined on the next date.
