- 3 & 4) Through this Petition, the Petitioner has impugned the vires of Section 4-C of the Income Tax Ordinance, 2001 and learned Counsel for the Petitioner submits that the issue in hand stands decided by way of a short order dated 22.12.2022 in C. P. No. D-5842/2022 and thereafter followed by reasons dated 13.01.2023, whereby, the Petitions have been allowed in certain terms. Learned Counsel submits that notice be issued to the Respondents and ad-interim orders passed in the earlier Petitions may also be passed in favour of the present Petitioner. He submits that now a Show Cause Notice has also been issued.

Let notice be issued to the Respondents as well as DAG for 07.02.2023 at 11:00 A:M. Till then, the Petitioner shall secure the disputed amount of Super Tax under Section 4(C) before the Nazir of this Court by furnishing Pay Order / Bank Guarantee within seven days from the date of this order, and upon furnishing such amount the Show Cause Notice shall remain in abeyance.
