By a common order dated 4.6.2021 passed in CP No.D-3309 of 2011, a bunch of petitions was disposed of challenging the levy of infrastructure fee. Learned counsel for the petitioners submit that these cases i.e. at Sr.No.11, 20, 39 & 42 of the main list as well as Sr.No.10&11 of the addl. list involve the same controversy which was disposed of earlier by the above referred common order/judgment and hence effect of the same may also be applied to these cases *mutatis mutandis*. Learned DAG and Addl. AG concede to the same.

Accordingly, these cases are disposed of on the same terms as the earlier cases involving question of infrastructure fee were disposed of vide judgment dated 4.6.2021 passed in CP No.D-3309 of 2011. Thus effect of the said judgment shall apply *mutatis mutandis* on these cases.
