ORDER

ZAFAR AHMED RAJPUT, J: Through instant criminal bail application, the applicant/accused Tariq Hussain Chandio s/o. Abdul Ghaffar has sought pre-arrest bail in Crime No. 22/2018, registered at P.S Waggan, under Section 489-F, 420, 504 P.P.C. Earlier his bail before arrest application bearing No. 348 of 2018 was heard and dismissed by the learned Additional Sessions Judge-II, Kamber, vide order dated 26.04.2018. The applicant was granted ad-interim pre-arrest bail by this Court vide order dated 27.04.2018, now he seeks confirmation of his bail.

2. Briefly stated facts of the case are that, on 22.04.2018, complainant Shabbir Ahmed Chandio lodged the aforementioned F.I.R. stating therein that he had good friendly relations with applicant/accused who, on 15.06.2017, borrowed Rs. 14,40,000/= from him for purchasing seeds, fertilizers and pesticide for his land, to which he issued a cheque bearing No. 87569201, drawn on Bank Al Falah, Larkana, which he (complainant) presented on 26.01.2018 for encashment, but the same was dishonored.

3. At very outset, the learned counsel for the complainant and A.P.G. do not oppose confirmation of interim bail granted to applicant subject to raising the bail amount from Rs.1,00,000/- to Rs. 6,00,000/- (Rupees six Lacs only), for that the counsel for the applicant has also recorded his consent.



4. Accordingly, the interim pre-arrest bail granted to accused, vide order dated 27.04.2018, is hereby confirmed subject to furnishing additional surety of Rs. 5,00,000/= with fresh P.R. Bond to the satisfaction of Addl. Registrar of this Court, within fifteen days hereof. In case the additional surety as directed herein above is not furnished within stipulated period, the interim bail order shall stand recalled.
