- 4. Through instant Crl. Bail Application, applicant Mir Adab Hussain Khan son of Bhambhoo Khan Golato seeks protective bail in Crime No.11 of 2000 registered at Police Station, Anti-Corruption Establishment (ACE) Kandhkot, under section 409, 467, 468, 477-A, 34, PPC R./w Section 5(2), Act-II of 1947.

Learned counsel submits that the applicant/accused was on bail in Sessions Case No.09 of 2006, arisen out of aforementioned crime/FIR and he was regularly attending the learned trial Court but due to tribal war with Jakhrani tribe in their area, he under compelling conditions could not come out from the area to attend the trial Court, resultantly his bail was cancelled by the learned trial Court and N.B.W was issued against him. Learned counsel further submits that the co-accused, who were attending the trial Court have been acquitted by the learned trial Court vide judgment dated 21st June 2016, however, the case of the applicant/accused has been kept on dormant file after declaring him as proclaimed offender. Learned counsel also submits that absence of the applicant/accused from the trial Court was neither deliberate nor willful but due to circumstance that his life was in danger due to tribal war, however, the applicant/accused is ready to appear before the trial Court along with fresh application for grant of bail to face the trial but since he has been declared proclaimed offender and perpetual warrant has been issued against him, he apprehends his imminent arrest before approaching the trial Court.

Without touching the merits and demerits of the case, the applicant/accused is admitted to protective bail for three days with effect from 03.11.2016 to 05.11.2016 (both days inclusive) subject to his furnishing solvent surety in the sum of Rs.50,000/- (Fifty thousands) and P.R bond in the like amount to the satisfaction of Additional Registrar of this Court to enable him to approach the learned trial Court for filing bail application. This order shall however cease to its effect on

05.11.2016 after Court hours. Meanwhile, operation of perpetual NBWs, if issued by \mathcal{N} the trial Court shall remain suspended.

Protective bail application stands disposed of.
