4. Through instant Criminal Bail Application, applicant Sattar son of Mohammad Uris Chahwan seeks protective bail in Crime No.107/2011, registered at Police Station Market, Larkana, under Section 302, PPC.

Learned Counsel submits that the applicant is innocent and has falsely been implicated in this case. He further submits that after investigation of aforementioned crime police submitted challan before the Court concerned showing the name of applicant as an absconder although he was very much available at his given address but for his arrest the police did not make any efforts and even he was unaware of lodgment of aforementioned F.I.R; however, the fact that such F.I.R has been registered against him came into his knowledge only when in his absence police raided his house for the execution of N.B.Ws issued by the trial Court. The learned Counsel also submits that the applicant/accused is ready to surrender before the Court concerned alongwith an application under Section 498, Cr.P.C for his pre-arrest bail but since the Court has already issued N.B.Ws,

therefore, he apprehends his immediate arrest before approaching the Court.

Without touching the merits and demerits of the case, applicant/accused is admitted to protective bail for five (5) days (with effect from 08.11.2016 to 12.11.2016), both days inclusive, to enable him to approach the Court concerned, subject to his furnishing surety in the sum of Rs.50,000/- and P.R bond in the like amount to the satisfaction of Additional Registrar of this Court.

This order shall, however, cease to have its effect on 12.8.2016 after Court hours or any earlier date when the applicant/accused shall surrender before the Court concerned, whichever occurs earlier. Meanwhile, the operation of N.B.Ws, if issued, against the applicant/accused shall remain suspended for five days.

This Criminal Bail Application stands disposed of.
