Admittedly eviction application filed by Respondent No.1 was decided through splendid judgment whereas, learned appellate court decided FRA in slipshod manner which practice cannot be appreciated. Learned appellate court was required to examine every aspect of the case, material available on record as well as evidence and findings accorded by the learned trial court; that practice was not adopted, therefore, learned counsel for respective parties are also agreed this aspect.

In view of above, impugned judgment dated 07.04.2021 passed by learned appellate court is set-aside and case is remanded to learned appellate court with direction that learned appellate Judge shall record the findings on available record and in view of judgment of trial court after hearing the parties without being influence by his earlier judgment dated 07.04.2021. It is expected that learned appellate court shall decide the appeal preferably within six [06] weeks.
