4. Applicants/accused Manthar Ali and Muhammad Murad seek protective bail in Crime No.72 of 2015 of PS Bakrani District Larkana registered for offences under Sections 302, 324, 114, 148, 149, 337-H(2), 386 PPC 6K 6/7 ATA, 1997. Presently case is pending before learned Judge, ATC, Larkana and N.B.Ws have been issued against the applicants/accused.

It is interalia contended that applicants/accused are prepared to surrender before trial Court but apprehend their arrest as learned trial Court is cordoned off by the police under the influence of the complainant. Serious malafides on the part of complainant and police is alleged.

Without touching merits and demerits of the case, protective bail is granted to the applicants for four days subject to their furnishing solvent surety in the sum of Rs.100,000/= each and P.R bond in the like amount to the satisfaction of Additional Registrar of this Court. Applicants are directed to surrender before the trial Court within stipulated period. In the meantime, N.B.Ws issued by the trial Court shall stand suspended. This order shall cease to operate after four days or on the day when applicants surrender before the trial Court, whichever is earlier. It is made clear that in case applicants failed to surrender before concerned Court within stipulated period, the surety bond shall stand automatically forfeited.
