4 & 5. Through instant criminal bail application, applicant/accused, namely, Sibghatullah son of Ghulam Hussain Jatoy, seeks protective bail in Crime No.02/2020, registered at Police Station Bahoo Khoso, for offence under Sections 344, 345, 346, 220, 506/2, 388, PPC.

At the very outset, learned Counsel submits that no NBW has yet been issued against the applicant by any Court but due to misunderstanding it has been mentioned in the application that trial Court has issued the same, for that he seeks apology. Apology is accepted.

The learned Counsel states that the applicant, who is government servant and employed in Police Department, is innocent and has falsely been implicated in this case by the complainant; that the police had produced the FIR before the Judicial Magistrate concerned, who vide order dated 21.02.2020 returned the same to Anti-Terrorism Court, Shikarpur while observing that the offence under Section 388, PPC falls under Section 6(2)(k) of the Anti-Terrorism Act, 1997; that the applicant is ready to surrender before the Court concerned along with an application under Section 498, Cr.P.C to prove his innocence, but as the applicant apprehends his immediate arrest, he seeks protection of law.

Without touching the merits and demerits of the case, the applicant/accused is admitted to protective bail for seven (07) days (with



effect from 26.2.2020 upto 03.03.2020 (both days inclusive) subject to furnishing solvent surety in the sum of Rs.50,000/- (Rupees fifty thousand) and P.R bond in the like amount to the satisfaction of Additional Registrar of this Court to enable him to appear before the Court concerned along with an application under Section 498, Cr.P.C. This order shall, however, cease to have its effect on 03.03.2020, after Court's hours or on any date when the applicant surrenders before the Court concerned, whichever occurs earlier.

This bail application stands disposed of.
