Through instant Constitutional Petition, the petitioner Sikandar Ali Khokher has prayed for the following relief(s):

- a) To direct the respondents No.4 to 6 to provide legal protection to the petitioner and his family members and ensure that no harassment is caused to the petitioner and his family members by the respondents No.1 to 3 at the instance of enemies of petitioner/accused persons of murder case crime No.67/2012 in which the petitioner is complainant.
- b) To direct the respondents No.1 and 2 not register false FIRs against the petitioner and his family members at the instance of enemies of petitioner/accused persons of murder case crime No.67/2012 in which the petitioner is complainant without permission of respondents No.5 & 6.
- c) Direct the respondents No.6/D.I.G Larkana to conduct a discrete enquiry into the matter in respect of the FIRs No.25/2013 and 126/2013 registered by the respondent No.1 against the petitioner and if these FIRs are found to be false, then strict legal as well as departmental action may be taken against the respondent No.1.


Notices were issued to the respondents as well as Addl. A. G. Comments have been filed by respondents, in which it is mentioned that following cases have been registered against accused Sikandar Ali :

 - 06) Crime No.57/2004 under section 324, 353, PPC registered at Police Station Naudero.
 - 07) Crime No.02/2003 under section 324, 353, PPC registered at Police Station Waleed.
 - 08) Crime No.32/2003 under section 9(c) of Control of Narcotic Substances, Act registered at Police Station Waleed.
 - 09) Crime No.25/2013 under section 9(c) of Control of Narcotic Substances Act registered at Police Station Naudero.
 - 10) Crime No.15/2012 under section 9 (b), Control of Narcotic Substances Act registered at Police Station Market.
 - 11) Crime No.126/2013 under section 9(c) of Control of Narcotic Substances Act registered at Police Station Naudero.

Learned advocate for the petitioner submits that presently cases at S.No.9 & 10 are pending before the learned Sessions Judge/Special ^{Court} Judge, for CNS, Larkana. We direct the trial Court to decide the cases within a period of three months strictly in accordance with law. It is further ordered that official respondents shall conduct themselves strictly in accordance with law and not to act contrary to law. In these circumstances, petition stands disposed of accordingly.
