Mr. Abdul Hamid Bhurgri, AAG along with Bashir Ahmed Abro, PDSP
and SIP Shaman Ali Khoso, SHO PS Mahota.

Through instant constitution petition, petitioner has prayed for the following relief(s):

- (a) "Direct the respondent No.8 to 10 to stop discriminatory policy and don't extend undue support to the respondent NO.1 to 3 and their gang but act honestly, impartially and fairly and provide equal treatment to all citizens as per constitutional guarantee.
- (b) To call the respondent No.1 to 3 to file undertaking before this Hon'ble Court that neither they will take the law into their hands nor will cause harassment to the petitioner and his brothers as well as other family members.
- (c) To direct the respondent No.4 and 5 to bound down the respondent NO.1 to mind his own business and don't indulge himself in criminal activities by misusing by his official powers by supporting the criminal activities of respondent's No.2 and 3.
- (d) Direct the respondent NO.4 to probe into the matter in respect of (i) misuse of funds of internal road in Village Dodai (ii) demolishing of office of the Field Assistant Agriculture Department Govt. of Sindh, one Masjid and compound walls of the houses of villagers and Masjid (iii) sources of the income of respondent NO.1 to 3 and their real brothers (iv) illegal encroachment upon property of Irrigation Department Government of Sindh, situated at the eastern bank of rice canal from Village Dodai to Larkana and its illegal sale for township (v) construction of link road from Larkana to village Dodai besides the eastern bank of Rice Canal (vi) the past and present assets of respondent No.1 to 3, their real brothers and ladies of their family including Agricultural land, plots and bungalows in Larkana city as well as flats in Karachi including vehicles and submit report before this Hon'ble Court for accountability through NAB."


Notices were issued to the respondents as well as A.A.G.
Comments have been filed by respondents/SSP Larkana as well as SHO
Police Station Mahota.

After hearing learned counsel for parties, by consent, petition is disposed of in the following terms:

- (1) Learned AAG undertakes on behalf of respondents No.7, 8 & 10 that police picket shall be established at the crucial point for the safety of the petitioner and other persons of the area in order to maintain law and order situation in the area.
- (2) The petitioner shall be provided protection in accordance with law.

Petition stands disposed of.
