This Court vide order dated 14.09.2020 allowed the transfer application for the following reasons:-

“By consent, Sessions Case No.358 of 2019 (Re: The State v. Ranjho Laghari and others) arising out of Crime No.118 of 2019 registered at P.S Bhan for offences under Sections 302, 337-H(ii), 504, 147, 148, 149 PPC, is withdrawn from the file of Additional Sessions Judge, Sehwan and it is made over / transferred to learned Sessions Judge Jamshoro for trying the same himself or he may make over / transfer to some other Additional Sessions Judge for expeditious disposal in accordance with law. Criminal Transfer Application No.S-95 of 2019 is allowed in the above terms.

Mr. Zahoor Ahmed Baloch, Advocate also appears in connected Criminal Miscellaneous Application No.S-122 of 2020 and Criminal Miscellaneous Application No.S-687 of 2019 (applications for cancellation of bail) and does not press the same. Accordingly, both the criminal miscellaneous applications are dismissed as not pressed.”

Thereafter, learned Additional Sessions Judge, Sehwan has submitted a letter dated 17th September 2020, in which it is mentioned that Sessions Case No.358/2020 (Re-The State v. Ranjho Leghari and others) u/s 302 PPC has been transferred from his Court to the Court of Sessions Judge, Jamshoro but the connected / off-shoot case bearing No.263/2019 (Re-The State v. Ranjho)

bearing Crime No.126/20129 u/s 25 Sindh Arms Act, 2013 of P.S Bhan is still pending on the file of Additional Sessions Judge, Sehwan. It is prayed that the off-shoot case may be transferred to the learned Sessions Judge, Jamshoro to avoid the conflict judgment.

Learned D.P.G. recorded no objection.

In the view of above, to avoid the conflict of judgment, Sessions Case No.263/2019 (Re-The State v. Ranjho) bearing Crime No.126/20129 u/s 25 Sindh Arms Act, 2013 of P.S Bhan is withdrawn from the file of learned Additional Sessions Judge, Sehwan and it is made over to the learned Sessions Judge, Jamshoro for trial alongwith main case.

Reference / letter is accordingly disposed of.
