Through instant criminal bail application, applicant/accused Asadullah alias Asad son of Pasha alias Shah Mohammad Khuhro, seeks protective bail in Crime No.03/2011, registered at Police Station Phuloo, District Khairpur, under Sections 302, 324, 337-H(2), 109, 147, 148, 149, PPC and 6/7 of Anti-Terrorism Act, 1997.

Learned Counsel for the applicant submits that the applicant was earlier granted protective bail vide order dated 02.4.2013 in CrI. Bail Application No.D-176/2013 by the Sukkur Bench of this Court and thereafter the applicant surrendered before the trial Court i.e. Special Judge, Anti-Terrorism Court, Khairpur Mirs, in Special Case No.97/2011 and he was subsequently admitted to interim pre-arrest bail by the trial Court, however, during pendency of the said case before the said Court the applicant was taken away forcibly by the Law Enforcing Agencies and after passing of long period he was released, however, meanwhile the trial court cancelled his pre-arrest bail application and later passed the judgment on 26.1.2015, whereby the case against the


applicant was ordered to be kept on dormant file. The learned Counsel further submits that the applicant intends to surrender before the trial court along with the applications under Section 498, Cr.P.C and 265-K, Cr.P.C, but he apprehends his immediate arrest before approaching the trial Court due to issuance of NBWs/proclamations by the trial Court, therefore, he seeks indulgence of tis Court.

Without touching the merits and demerits of the case, applicant is admitted to protective bail for 10 days from today upto 03.11.2017 subject to his furnishing solvent surety in the sum of Rs.100,000/- (Rupees One Lac only) and P.R bond in the like amount to the satisfaction of Additional Registrar of this Court. Meanwhile, the NBWs/proclamation issued by the trial Court shall remain suspended upto 03.11.2017.

This bail application stands disposed of.
