Through instant constitution petition, the petitioner Sabir Ali has prayed for the following relief(s):-

- (a) That this Honorable Court may kindly be pleased to accept the instant petition and further be pleased to admit it for regular hearing.
- (b) That this Honorable Court may kindly be pleased to direct the Sessions Judge, Jacobabad to conduct surprise visit/raid himself or through any Civil Judge/Judicial Magistrate, subordinate to him at P.S Mubarakur to ascertain the detention of detainee Imam Bux and eight cattle viz. buffalo illegally taken away by the respondent No.1 and furnish such report to Honorable Court on or before next date of hearing.
- (c) That this Honorable Court may kindly be pleased to direct the respondent No.1 to produce record of the detainee namely Imam Bux s/o Shafi Mohammad Banglani, if any, before this Honorable Court along with detainee and eight buffalos illegally taken away by the respondent No.1 from the house of petitioner and its proceeding according to law.
- (d) That this Honorable Court may kindly be pleased to direct the respondent No.1 to record the statement of the petitioner in view of above submissions and if any cognizable offence makes out, this Honorable Court may further be pleased to direct the respondent No.1 to reduce it in writing in terms of section 154, Cr.PC by making compliance with concerned court as required by section 157, Cr.P.C. under intimation to this Honorable Court.
- (e) That this Honorable Court may kindly be pleased to direct the respondent No.7 to conduct inquiry through an impartial and senior police officer and then take stern departmental action against the respondent No.1 and 2 under intimation to this Honorable Court.
- (f) That this Honorable Court may kindly be pleased to direct the official respondents particularly respondents No.5 and 6 to provide legal protection to the petitioner and his family and not to cause any kind of harassment to them through respondents No.1 to 4.

Notices were issued against the respondents as well as Addl. A.G Sindh. _{55P Jacobabad} was directed to produce the detainee Imam Bux before this Court. _{5HO} Police Station Mubarakpur appeared and produced copy of remand order granted by Civil Judge & Judicial Magistrate, Thul which reflects that remand of detainee Imam Bux has been obtained in Crime No. 03/2015 under section 447, 448, 427, PPC registered at Police Station Mubarakpur. As regards cattle are concerned, SHO Police Station Mubarakpur present in Court submits that proceedings under Section 550, Cr.P.C. have been carried out.

In view the comments and copy of the remand order, n o relief can be granted to petitioner in this petition. Therefore, petition is dismissed.
