Through the instant constitutional petition, the petitioners have prayed for the following reliefs:-

- “(a) To quash the FIRs bearing Crime No.26/2016 under Section 457, 380 & 34 PPC, Crime No.27/2016 under Section 457, 380 & 34 PPC, Crime No.28/2016 under Section 457, 380 PPC, Crime No.29/2016 under Section 456, 34 PPC at P.S Sarhari, Crime No.30/2016 under Section 457, 380 & 34 PPC at P.S Sarhari being false and fabricated one.
- (b) To direct the respondents No.4 to 8 not to cause any sort of harassment to the petitioner and his relatives at the instance of political rivals.
- (c) To direct the respondents No.2 to 4 to provide safety and protection to life, property, honour and prestige to the petitioner, her family members and relatives.
- (d) Any other relief which this Honourable Court deems just, fit and proper may also be provided to the petitioner.”

Notices were issued against the respondents as well as A.A.G. D.P.G is also present and waives the notice. Parawise comments are filed on behalf of respondents No.2 to 8, in which the allegations have been denied. However, the respondent No.8 in his comments has stated that Darya Khan @ Daro Zardari, Lal Bux @ Lalo Zardari, Nazir Zardari and Ghulam Hyder Zardari, all by caste Zardari and sons of Muhammad Zardari and brothers of petitioner Jam Zardari as well as brothers-in-law of petitioner Mst.Momal are involved in various cases registered at P.S Sarhari.

Learned D.P.G pointed out the FIRs bearing Crimes Nos.26/2016, 27/2016, 28/2016, 29/2016 and 30/2016 after usual investigation have been challaned before the competent Court of Law.

Learned Counsel for petitioner admits that petitioners have not been nominated as accused in any of the FIRs mentioned above.

Learned Counsel for petitioner could not satisfy the Court that petitioners are not aggrieved persons. More so, after usual investigation final reports have been filed. Accused may approach the trial Court for

seeking relief. As regards to the prayer of the petitioners they feel insecure, we direct the police officials to provide protection to the petitioners in accordance with law.

Petition stands disposed of in above terms.
