Through the instant constitutional petition, the petitioners Mst.Naidan and Muhammad Ramzan have prayed for the following reliefs:-

- "A. To Direct the respondents No.1 and 2 in respective capacities to restrain the respondents No.3 and 4 from harassing the petitioners and their well wishers at the behest of respondents No.5 to 11 in any form or manifestation and treat them like respectable citizens as guaranteed in the Constitution of Islamic Republic of Pakistan.
- B. To direct the respondents No.1 and 2 to provide legal protection of life, honour, prestige and property to the petitioners and their well wishers against the sheer highhandedness of the respondents No.3 to 11.
- C. To direct the respondents No.3 to 11 to furnish statements before his Honourable Court that they will not harass the petitioners and their well wishers in any form or manifestation.
- D. To declare the act of the respondents No.5 to 11 declaring the petitioners "karo-kari" (liable for honour killing) as illegal, unlawful and against the Teachings of Islam.
- E. To restrain the official respondents from registering any false and fabricated FIR against the petitioners or their well wishers without prior permission of this Honourable Court.
- *F.* Costs of the petition may be saddled upon the respondents.
- G. Any other relief(s) which this Honourable Court deems fit, just and proper in favour of the petitioner".

Notices were issued against the respondents as well as Additional Advocate General, Sindh. Today, the learned A.A.G has filed the parawise comments on behalf of respondent No.1/SSP Badin, respondent No.2/SSP Hyderabad, respondent No.3/SHO P.S Badin and respondent No.4/SHO P.S GOR, Hyderabad. Senior Superintendent of Police, Badin in his comments has denied all the allegations of the petitioners and stated that petitioner No.1 Mst.Naidan has contracted marriage with petitioner No.2 Muhammad Ramzan with her wish and freewill without consent of her parents. It is further mentioned in the comments that no FIR has been lodged against petitioner No.2 Muhammad Ramzan by the parents of the petitioner No.1. However, the Senior Superintendent of Police, Badin has undertaken that the official respondents shall act strictly in accordance with law and protection to the petitioners shall also be provided.

Mr. Zeeshan Ali Memon, Advocate has filed power on behalf of private respondents No.6 to 9, who are present in Court, and stated that the private respondents will not cause any harassment to the petitioners.

Learned Additional A.G also undertakes that official respondents/police officials, present in Court, shall provide protection to the petitioners and no harassment whatsoever shall be caused to them.

In view of the parawise comments filed by the police officers/officials and undertaken given by learned A.A.G as well as Counsel for private respondents, the Counsel for petitioners expressed his satisfaction and does not press the instant constitutional petition more and it is accordingly disposed of. However, Senior Superintendent of Police, Badin is once again directed to provide protection to the petitioners in accordance with law and shall ensure that no harassment is caused to them.

Petition stands disposed of in above terms.
