Learned counsel for the petitioner in JCM No.51 of 2022 has assisted me in relation to the dispute between the parties. In essence, it is stated that in terms of the scheme of arrangement, an understanding between the directors is reached and that would lead to the withdrawal of pending litigation i.e J.C.M. No.37 of 2020 and suit No.1649 of 2020. The scheme of arrangement is available at page-157 in J.C.M No.51 of 2022. It seems as if all parties having interest in petitioners No.1 and 2 have been resorted to in view thereof it is deemed appropriate to pass orders for the withdrawal of



the connected JCM No.37 of 2020 and Suit No.1649 of 2020. Order accordingly.

JCM No.37 of 2020 and Suit No.1649 of 2020 are dismissed as withdrawn along with pending applications with no orders as to costs.

As far as JCM No.51 of 2022 is concerned, let the meetings of two companies being demerged through this scheme of arrangement be convened on the respective dates, as suggested and the notice in the meantime be issued to the SECP for filing their para-wise comments. In the meantime, publication may also be effected at the earliest. JCM No.51 of 2022 be fixed in about three weeks thing.
