Through instant criminal bail application, applicants, namely, 1.Naeem Ahmed son of Hidayatullah, 2. Hidayatullah son of Jam, 3.Naveed Ahmed son of Hidayatullah, 4. Nadeem Ahmed son of Hidayatullah, and 5.Malhar son of Mohammad Sallah, all by caste Bhutto, seek pre-arrest bail in Crime No.36/2018, registered at Police Station Staurt Ganj, Shikarpur, for offence under Sections 337-A(i), 337-F(i), 337-H(2), 114, 504, 147, 148, PPC. Their earlier application for grant of pre-arrest bail bearing Crl. Bail Application No.631/2018 was heard and dismissed by the learned III-Additional Sessions Judge, Shikarpur vide order dated 22.6.2018. The applicants were admitted to ad-interim bail by this Court vide order dated 27.6.2018, now they seek confirmation of the same.


The learned Counsel for the complainant at the very outset states that the parties have entered into compromise, therefore, he has no objection if the ad-interim pre-arrest bail already granted to the applicants vide order dated 27.6.2018 is confirmed on same terms and conditions.

The learned Addl. P.G considering the fact that the alleged offence is compoundable, also records his no objection for confirmation of ad-interim pre-arrest bail already granted to the applicants.

It appears that after investigation police has submitted the challan against the applicants, hence, they are not required for further

investigation. There is no allegation of misusing of concession of interim pre-arrest bail by the applicants. The alleged offence does not fall within the prohibitory clause of Section 497, Cr.P.C. The parties have admittedly entered into a settlement outside the Court, therefore, interim pre-arrest bail already granted to the applicants on 27.6.2018 is hereby confirmed on the same terms and conditions.

This criminal bail application stands disposed of.


