- 4. Through this application, applicants/accused, namely, 1. Imran Khan osn of Mohammad Ibrahim Junejo, 2. Altaf Hussain son of Mohammad Urs Shaikh, 3. Tarique Hussain son of Ghulam Shabir Junejo, and 4. Junaid Ahmed son of Mohammad Ishaque Arain, seek protective bail in Crime No.02/2018, registered at Police Station ACE, Shikarpur, for offence under Sections 161, 406, 409, 467, 468, 477-A, 34, PPC read with section 5(2) Act II of 1947.

The learned Counsel states that the applicants, who are government contractors, are innocent and have falsely been implicated in this case by the ACE Police, Shikarpur. He further submits that there is delay of 02 years in the lodgment of FIR, wherein the applicants are not nominated and their names were subsequently introduced in the challan without any proof/evidence; however, per learned Counsel, the applicants/accused are ready to surrender before the Court concerned along with an application under Section 498, Cr.P.C to prove their innocence, but since in the challan the applicants/accused are shown as absconders and the trial Court has issued NBWs, the applicants apprehends their imminent arrest, hence they seek protection of law.



Without touching merits and demerits of the case, the applicants/accused are admitted to protective bail for seven (07) days (with effect from 31.8.2018 to 06.9.2018) subject to furnishing solvent surety in the sum of Rs.30,000/- (Rupees thirty thousand only) each and P.R bond in the like amount to the satisfaction of Additional Registrar of this Court. Meanwhile, the operation of NBWs, if issued against the applicants by the trial Court, shall remain suspended. This order shall, however, cease to have its effect on 06.9.2018, after Court's hours or on any date when the applicants surrender before the Court concerned, whichever occurs earlier.

This bail application stands disposed of.
