Applicant Mst. Saadia Memon present in person.

1. Deferred for the time being.

2&3. Petitioner present states that she is working as Principal of Sindhiana School & College, Qasimabad, Hyderabad situated near bypass and PS Bhitai Nagar. She further states that one Mst. Tahzeeb Ara complainant of No.64/2025 of PS Bhitai Nagar along with others is encroacher and occupied a public street surrounding the said School; however, despite clear orders of this Court on 03.01.2025, 13.01.2025 and finally on 27.01.2025 passed in 1<sup>st</sup> Appeal No.1 of 2025 to remove the encroachment, the private respondent and others instead to remove encroachment, attacked upon the School and did injured her, her husband and teachers as well as students of the School and tortured upon the applicant and her family members. She further states that husband of said Mst. Tahzeeb Ara is working at PS Bhitai Nagar and in order to create pressure upon the applicant and School administration, the respondent No.5 namely Mst. Tahzeeb Ara, by using her husband lodged a false FIR bearing crime No.64/2025 against the applicant, her husband and other teachers of the School for the offence under sections 397, 363, 427, 506, 504, 337-A (i), 342, 337-F (i) PPC at PS Bhitai Nagar. She further submits that no such incident has taken place nor they have committed any offence. Apparently, there appears a dispute over encroachment of the Street surrounding the School, where applicant is a Principal but allegedly the husband of the complainant namely Nazeer Ahmed by using his powers and his position lodged a

false FIR malafidely with ulterior motives against the applicant, her husband and other teachers of the School. There were also clear directions of this Court for removal of encroachment over Public Street surrounding the School. The applicant prays for protection.

Be that as it may, let notice be issued to the respondents as well as learned A.P.G. Sindh. Meanwhile, no anyone nominated in the said FIR shall be arrested in crime No.64/2025, under sections 397, 363, 427, 506, 504, 337-A (i), 342, 337-F (i) PPC registered at PS Bhitai Nagar. The proceedings as well as investigation of the said FIR are stayed. The Senior Superintendent of Police, Hyderabad is directed to probe in the matter and submit such compliance report and appear in person on the next date of hearing. Respondent No.4 / SHO PS Bhitai Nagar and I.O. of the case so also the husband of the complainant namely Nazir Ahmed, shall be present in person along with relevant record on the next date of hearing. The SHO PS Bhitai Nagar is directed to serve the notices upon the respondent No.5 and her husband Nazir Ahmed without fail.
