<p class=MsoNormal style='text-align:justify;text-indent:.5in;line-height:200%'>According to the prosecution, on 18.7.2005, at 1230 hours, a team of investigation branch of police, headed by Sub-Inspector Jawed Akhter of Police Station Al-Falah, came across five persons, namely, Faiz Muhammad Chandio, Ghulam Nabi Saharan (present applicant), Ghulam Muhammad, Muhammad Saleem Soomro and Tahir Muhammad Soomro,

going along Baba Wilayat Ali Shah road, Malir City, Karachi. Each of them had a bag hanging down his shoulder. Every bag contained four kilograms of explosive substance, a pistol and six cartridges. In addition, applicant's bag contained a detonator with ignition fuse and a wire two or three meters in length. All of them were arrested and booked, inter alia, under Section 4/5 of the Explosive Substances Act, 1908. Till date the applicant is behind the bars and the diary of the trial Court shows that inspite of issuance of process to the prosecution witnesses more than 40 times, the prosecution has failed to produce any witness. </p>

<p class=MsoNormal style='text-align:justify;text-indent:.5in;line-height:200%'>It is the right of every accused to be put to trial within a reasonable time. The applicant has remained in custody for more than 2 years and 10 months. The charge was framed on 31.1.2006 but inspite of the continuous issuance of process for more than 40 times, the prosecution has failed to produce any witness. The learned State counsel has failed to explain such an indifferent attitude on the part of the prosecution which clearly amounts to abuse of the process of law as well as of the court. Accordingly, the applicant is directed to be released on bail on giving one surety in the sum of Rs.100,000/- and personal bond in the like amount to the trial Court. </p>

<p class=MsoBodyTextIndent2>4&5) Learned counsel for the petitioner contends that while refusing to allow ejectment on the ground of personal need the Rent Controller as well as Appellate Authority have ordered ejectment on the ground of default, notwithstanding, the fact that the petitioner had been depositing rent regularly in Court. He further contends that with the intervention of respondent No.1's brother Muhammad Ali, the petitioner has tried to settle the dispute and has agreed to purchase the shop in-question for rupees 9.5 million and has also made part payment of rupees four lacs. He has filed copy of such receipt. The learned counsel further contends that he can produce the respondent No.1 before this Court to confirm the talks of compromise. However, according to the learned counsel, the trial Court has issued writ of possession with police aid, which is likely to defeat, the compromise arrived at between the parties. </p>
