**Respondents No.2 and 4**

*It is therefore humbly requested that kindly be passed the orders in the larger interest of justice.*

- 1. To allow to verify their travel documents through Ministry of foreigner affairs for confirmation of their genuineness.*
- 2. To allow to verify their status, criminal record CRO / CRI accordingly because they are illegally staying in Pakistan since long.*
- 3. To direct D.G NADRA Sindh to verify the petitioner through Bio-Matric for NADRA registration, if petitioners register in NADRA, their CNIC's may be canceled/Blocked and also provide clearance certificate to petitioners.*
- 4. To allow, to deport to their native country, after completing legal and required formalities under the foreigner Act 1946.*

- iii. *Letter from Foreign Registration Office, Special Branch, Karachi having the request for their deportation*
- iv. *Travel permit issued by Special Branch*
- v. *A letter issued from Additional Inspector General Police to Foreign Registration Office.*
- vi. *Exit Permit*

*In view of the above, whenever any of the petitioner will appear at FIA Immigration Counter along with lawful requisite documents, the individual will be allowed to proceed abroad as per law subject to any conduction.*
