Principal, BSAMS CMW School, Jacobabad and Munir Ahmed Soomro,
Deputy DHO (RMNCH), Jacobabad.

Respondents No.6 & 7 have filed statements/comments, which
are taken on record. Learned Counsel for the petitioner also files Affidavit-in-
Rejoinder against comments filed by respondent No.5.

Learned Counsel for the petitioner submits that the petitioner
fulfilling the requisite criteria applied for admission in Community Midwifery
Training Course Batch 17 for the Academic Session 2025-27 and she
appeared in the interviews held on 02.9.2025 and qualified in the test. Per
learned Counsel, the petitioner possessing above percentage in educational
qualification i.e. Matriculation with 67.53 percentage and Intermediate with
75.18 percentage was entitled and eligible to be given admission, but the
respondents acting under pick and choose policy selected their blue eyed
candidates on the basis of influence, while the petitioner has been deprived of
such admission; otherwise, she is entitled to be given admission to above
course purely on merit basis.

Pursuant to notices, the respondents No.6 & 7 have appeared
and have filed statement adopting the comments already filed by respondent
No.5. The respondent No.5/District Health Officer, Jacobabad, who is said to
be the chairman of admission selection committee, in his comments has
mentioned that the total 122 candidates had applied for the above admission,
out of which 117 candidates appear in the interview and only 30 candidates
were selected on merit as per selection criteria. From perusal of the

Attendance-Sheet of the Admission Committee for the admission of Community Midwives under Academic Session 2025-27 at Begum Saeeda Ahmed Mian Soomro Community Midwifery School, Jacobabad, dated 02.09.2025, it appears that 122 candidates had appeared, which negates the assertion of respondent No.5 made in his comments. When enquired, the respondents No.7 have not replied satisfactorily, while stating that it is a clerical mistake.

In such circumstances, respondent No.5 is directed to appear before the Court in person on the next date and to explain the above anomalous position.

Respondent No.7 submits that the classes of above course have been started in the BSAMS CMW School, Jacobabad since last about 1½ month. Learned Counsel for the petitioner submits that since she has been deprived from admission in Community Midwifery Training Course Batch 17 for the Academic Session 2025-27 without any legal justification, therefore, some interim relief may be granted in her favour. Accordingly, subject to outcome of this petition, the respondents No.5 to 7 are directed to admit the petitioner in the above course provisionally and allow her to attend the classes by assigning a provisional enrolment number to her. To come up on 07.11.2025. Office is directed to provide copy of order to learned AAG, for compliance.
