The official respondents have filed their statements through the learned A.A.G, which are taken on record. Copies thereof have been supplied to learned counsel for the parties. Mr. Rafique Ahmed K. Abro, learned Advocate, files power on behalf of respondent No.9 along with a statement supported by certain documents; copies whereof have also been furnished to learned counsel for the petitioner.

Learned counsel for the petitioner submits that the official respondents, at the behest of the private respondents, are causing harassment to the petitioner, which has constrained him to approach this Court. He prays that the official respondents be directed to act strictly in accordance with law and refrain from causing any harassment to the petitioner.

Learned A.A.G submits that the official respondents are duty-bound to act strictly in accordance with law and shall provide protection to the petitioner, as and when required, strictly in accordance with law.

Learned counsel appearing for respondent No.9 submits that a dispute regarding agricultural land is ongoing between the parties. However, he states that the private respondents shall act strictly in accordance with law and that appropriate proceedings regarding the agricultural land shall be instituted before the competent forum.

Learned counsel for the petitioner, after examining the statements filed by the official respondents as well as the statement of learned counsel for respondent No.9, submits that he would be satisfied if the petition is disposed of with directions ensuring that no harassment is caused to the petitioner and that protection is provided to him strictly in accordance with law.

Accordingly, the petition is disposed of with directions to the official respondents to act strictly in accordance with law and to ensure that no harassment is caused to the petitioner. The official respondents are further directed to provide protection to the petitioner, as and when required, strictly in accordance with law. It is, however, clarified that any civil dispute between the parties, if pending or instituted, shall be decided by the competent forum on its own merits and strictly in accordance with law, without being influenced by this order.

Let a copy of this order be transmitted to the concerned official respondents and to the learned Additional Advocate General, Sindh, for compliance.
