- 3. Exemption granted subject to all just exceptions.
- 4. The applicant has approached this court for grant of protective bail in Crime No.09 of 2021, registered at Police Station Karim Bux for offenses punishable under sections 302,324,148,149, 504 PPC.

It is, inter alia, contended by the learned counsel for the applicant that the applicant has been charge-sheeted in Crime No.09 of 2021, registered at Police Station Karim Bux for offenses punishable under sections 302,324,148,149, 504 PPC; and, he has been shown absconder in the aforesaid crime. Per learned counsel the concerned Magistrate has issued NBWs against him, therefore, he has directly approached this court for grant of protective bail, enabling him to surrender before the learned trial court. He added that there is a delay of two days in lodging of FIR for which no plausible explanation has been furnished by the complainant. Per learned counsel, there is a conflict between medical and ocular testimony, therefore the case of the applicant needs to be looked into by the learned trial court for grant of his pre-arrest in the aforesaid crime. Be that as it may, without touching merits of the case, the applicant Dil Murad son of Darzi Khan Bangulani is enlarged on protective bail for 07 days, enabling him to appear and surrender before the learned trial court, subject to his furnishing solvent surety in the sum of Rs,100,000/-(Rupees One Lac) and PR bond in the like amount to the satisfaction of Additional Registrar of this Court. However, it is made clear that if the applicant fails to surrender before the learned trial court within the stipulated period as discussed supra, his surety shall stands forfeited, without further order of this court. This order shall seize to have its effect on 05.8.2021, or when the applicant surrender before the trial court whichever is earlier.

This bail application stands disposed of in the above terms.
