ORDER

Adnan-ul-Karim Memon, J.- Petitioner namely Mst. Kiran has filed this Petition under Article 199 of Islamic Republic of Pakistan, seeking following relief:

- 1. In light of the foregoing, the Petitioner respectfully prays that this Honorable Court may be pleased to:*
- a) Direct NADRA to immediately process and issue CNICs for the Petitioner.*
- c) Grant any other relief deemed appropriate by this Honorable Court.*

2. Learned counsel for the Petitioner submits that after fulfillment of all legal requirements and submission of the necessary documents before the Respondent No.3, the CNIC of the Petitioner is not being issued. The Respondents have unjustly refused to process the application on the pretext of procedural issues, thereby causing immense hardship to the Petitioner. Learned counsel submits that denial of CNIC prevents the Petitioner from accessing essential services such as education, healthcare, and legal recognition, which amounts to a violation of her constitutional rights, therefore, she has approached this Court for issuance of CNIC which is also fundamental right of the Petitioner.

3. Learned counsel representing on behalf of Respondent Nos.2 and 3 submits that the Petitioner Kiran claimed to be daughter of deceased Riaz Ahmed, his bearing CNIC No. 42000-6523424-5 and Aneela Bibi. However, the Petitioner Kiran is required to process with mother Death Certificate, father Death Certificate and verified CBRC issued from UC concerned and verifier grandmother Zaibunnisa w/o. Sanaullah bearing CNIC No. 42101-8113513-0. In this regard, the Petitioner is required the Marriage Certificate with spouse Muhammad Shakeel bearing CNIC No. 42101-3189120-3 as his spouse name mentioned as Zoya not Kiran. He submits that further documents is required for further investigation. It is further submitted that the Petitioner also claimed to be

the daughter of Riaz Ahmed and Aneela Bibi and as per Death Certificate, Riaz Ahmed died in the year 2012 and Aneela Bibi was died in the year 2022, but the Petitioner's neither registered in NADRA database nor obtained B Form, CNIC and FRC. Hence, the claim of the Petitioner is not maintainable at this stage and subject petition is liable to be dismissed. He further points out that the Petitioner also claimed to be the spouse of Muhammad Shakeel, but as per record of NADRA, the spouse name of Muhammad Shakeel is Zoya not Kiran which is disputed of the case, however, after arguing the matter at some length, learned counsel for the Petitioner submits that the Petitioner will approach the NADRA Office at Sakhi Hassan for further process of her unblocking of the CNIC and further information so far as. Learned counsel for NADRA has no objection to the aforesaid proposition, in such circumstances without touching the merits of the case, the competent authority of NADRA is directed to facilitate to the Petitioner, for their aforesaid relief. Her cases shall be processed in accordance with the law within two weeks, without creating bottleneck subject to all just exception as provided under the law.

4. This Petition stands *disposed of* in the above terms.
