Adnan-ul-Karim Memon, J. – Petitioners Syeda Sunderta Shah & Syeda Amna Shah have filed this Constitution Petition under Article 199 of the Islamic Republic of Pakistan 1973 seeking the following relief:

- i. Declare the actions of Respondents regarding non-release of pension, pensionary benefits, commutation, leave encashment, financial assistance, group insurance, and gratuity fund as illegal, against the fundamental rights as guaranteed under the Constitution of Islamic Republic of Pakistan, 1973.
- ii. Direct the Respondents to release the pension, commutation, leave encashment, financial assistance and group insurance to the Petitioner along with interest.
- iii. Any other relief(s) this Hon'ble Court may deem fit in the given circumstances and in the great interest of justice.

2. Learned counsel submits that the Petitioners' late father was appointed as Excise Inspector (BPS-14) on 11-02-2002 and tragically died in a road accident on 06-07-2014. At that time, the Petitioners were minors and unable to claim their lawful dues. Their mother had been divorced and later remarried, leaving the Petitioners as the only legal heirs, as established through heirship documents. After attaining majority and obtaining CNICs, the Petitioners requested the release of their father's pension, gratuity, GP Fund, financial assistance, group insurance, and other dues. Despite submitting all documents and making repeated representations over nine years, the Respondents have failed to release the dues, causing financial hardship and mental distress. The inaction is alleged to be arbitrary, illegal, and in violation of Articles 4 and 25 of the Constitution, as well as principles of natural

justice, equity, and Supreme Court precedents. The counsel urges this Court to direct the Respondents to release all pensionary and allied benefits with lawful interest. This Court, vide order dated 27.01.2026, directed the competent authority to release the pension and other dues. Learned A.A.G., Sindh, files a statement confirming the status and details of all family pension benefits of the legal heirs of Late Syed Jahangir Shah, Ex-ETI, which reads as under: _

4. Learned A.A.G., Sindh requests one more month to coordinate with the Deputy Commissioner for the disbursement of the remaining pensionary benefits. The petitioner’s counsel agreed and submitted that the petitioners shall coordinate with the office concerned.

5. The request so made by the learned AAG seems to be reasonable and is acceded to, and this Petition, along with pending application(s), is disposed of with the officials’ undertaking in Court.
