3. Through this Application, applicant/surety submits that on 11.01.2024 accused/applicant Kamran Ali son of Arbab Ali Mirani was granted transitory-cum-protective bail for 07 days in NAB Reference No.13/2018, thereby enabling him surrender before the Court concerned for seeking appropriate relief. He next submits that in compliance of order dated 11.01.2024 applicant/surety Farhan Ali Mirani had stood surety on behalf of above-named accused by depositing Special Savings Certificate of Rs.50,000/- before Accountant of this Court. After furnishing surety, applicant/ accused had surrendered before the trial Court/Judge, Accountability Court-III, Sukkur, where he being proclaimed offender was taken into custody and remanded to jail vide order dated 13.01.2024; however, subsequently he was released on post arrest bail by the same NAB Court vide order dated 13.03.2024. In support of his contentions, he has placed on record certified copy of order dated 13.1.2024 as well as photocopy of release writ dated 15.3.2024 issued by the trial/NAB Court and submits that purpose of the bail bond as well as surety has been served; hence, surety document/Special Savings Certificate deposited by him before this Court is no longer required and prays for its release/withdrawal.

Mr. Oshaq Ali Sangi, learned Asst. Attorney General, waives notice of listed application and after going through file records no objection. Accordingly, instant application is allowed. Office is directed to release/hand over surety document/Special Savings Certificate, deposited by the applicant/surety before this Court, after proper verification, identification and as per rules.
