4. Learned Counsel submits that the applicant was earlier granted five days' protective bail by this Court vide order dated 22.2.2024 passed in Cr. Bail Application No.S-114/2024; however, subsequently it came to his knowledge that the FIR in question has been submitted before the Anti-Terrorism Court, Kashmore at Kandhkot, where NBWs have been issued against the applicant.

Be that as it may, without touching merits or demerits of the case, applicant Akhtar Hussain son of Hidayatullah Bajkani is admitted to protective bail for five (05) days from today in the Crime No.43/2020, registered at PS Guddu, District Kashmore at Kandhkot, u/s 365-B, 364-A, 376, 148, 149, PPC & 3/4 S.C.M.R. Act 2013 r/w sections 6/7, Anti-Terrorism Act, 1997, subject to his furnishing solvent surety in the sum of Rs.50,000/- (Rupees fifty thousand) and P.R Bond in the like amount to the satisfaction of Additional Registrar of this Court, thereby enabling him to surrender before the Court concerned for seeking appropriate relief. Meanwhile, operation of NBWs issued against the applicant by the trial Court in the above crime shall also remain suspended for five days.

Learned Counsel submits that the surety furnished by the applicant in Cr. Bail Application No.S-114/2024 is still in tact; hence, the applicant may be allowed to remain on same surety. Order accordingly. However, the applicant is directed to submit fresh bond.

This protective bail granting order shall cease to operate on expiry of 05 days from today i.e. on 30.02.2024 or any earlier date when

the applicant surrenders himself before the Court concerned, whichever is earlier.

Instant bail application stands disposed of in above terms.
