1. Urgency granted.
  2. Through this application, respondent No.4 Muhammad Waheed submits that lastly the case was fixed in Court on 06.03.2026 and fixed date i.e. 23.04.2026 was given, however, he pleads urgency on the ground that the date given by the Court is too long as he has to travel abroad, besides he has maintained application bearing CMA No.5667 of 2026 listed at serial No.3 seeking activation / un-blocking of his CNIC, hence he requests that by granting this application, it may be converted into application for antedate and the application listed at serial No.3 may be taken up for hearing today. Record supports his contentions. Order accordingly.
  3. Through this application, respondent No.4 submits that at the time of filing of this petition, he was in abroad and due to his absence, his CNIC was directed to be blocked by way of order dated 13.11.2019. He further submits that later on the petition was also disposed of on 06.02.2020, however, his CNIC has not been activated / un-blocked by the NADRA authorities. He submits that in so far as the FIR No. 208/2019 under Section 506/509/504/34 PPC of PS Sherhshah, Karachi registered against him is concerned, he has also been acquitted from the charge of said FIR by way of order dated 05.06.2025; therefore, by granting this application, the embargo imposed in terms of order dated 13.11.2019 may be relaxed and NADRA authorities may be directed to activate / un-block his CNIC.

Ms. Shazia Hanjrah, learned DAG, who is present in Court in connection with some other cases, waives notice of the application and records her no objection to the grant of this application.

Since by way of order dated 05.06.2025 passed by the XVth Civil Judge & Judicial Magistrate, Karachi (West) (Re- The State V/s Muhammad Waheed & others) being outcome of FIR No.208/2019, under Section 506/509/504/34 PPC registered at PS Sherhshah, Karachi (certified copies of the order and the FIR have been annexed along with the application), respondent No.4 Muhammad Waheed has been released under Section 249 Cr.P.C. and he is no more required by any Court of law, hence in view of the above, this application is hereby allowed. The NADRA authorities are directed to activate / un-block the CNIC of respondent No.4 namely Muhammad Waheed son of Muhammad Hanif. A copy of this order shall be sent by fax to the Director General NADRA for compliance. A copy of this order shall also be provided to the office of the Additional Attorney General for Pakistan for correspondence and compliance. The application stands disposed of.
