Mr. Khalid Hussain Lakho, DPG. along with Inspector/SHO Waheed Ali, SHO PS Hussain, I.O./SIP Imtiaz Ahmed PS Hussainabad, Muhammad Ilyas, DSP (Legal) on behalf of SSP Hyderabad, Inspector Manzoor Ali, Legal Branch, SSP office Hyderabad and SIP Sanwan Khan PS Nasarpur.

Mr. Shakir Ali Shar Advocate has filed vakalatnama on behalf of Respondent No.8, who is also present in Court. Vakalatnama is taken on record.

The alleged detainee, Mst. Um-e-Farwa, has been produced before the Court by SIP Imtiaz Ahmed, P.S. Hussainabad, who is also the Investigating Officer of the main case. From her appearance, she appears to be a major. She states that, being sui juris and major, she has contracted marriage with the applicant, Raza Haider son of Afaque Haider, against the wishes of her parents. She further states that SIP Imtiaz Ahmed recorded her statement through video, wherein she stated, "I want to go with my father." According to her, the said statement was made under duress and severe pressure from her family. She states that she wishes to go with her husband, Raza Haider (applicant), and requests that her earlier video statement recorded by SIP Imtiaz Ahmed be disregarded. She further seeks protection.

SIP Imtiaz Ahmed, the Investigating Officer of the main case, has recorded the statement of the alleged detainee, Mst. Um-e-Farwa, in Court today, wherein she has stated that she wishes to go with her husband, Raza Haider; however, she apprehends harm at the hands of his father and other family members. Her statement is taken on record.

Since the purpose of filing this application stands achieved on appearance / production of the alleged detainee Mst. Um-e-Farwa in Court today, the same is disposed of accordingly along with pending application.

However, the police officials present in Court are strictly directed to escort the alleged detainee Mst. Ume-e-Farwa. The applicant Raza Haider and Mst. Um-e-Farwa being husband and wife shall be provided protection as and when required. The Respondent No.8 Syed Muzamil Hussain Shah, Fardeen Shah, Jehanzeb Shah, Sabat Shah and Taqi Raza Shah (father, brother and cousins) are directed not to cause any harassment to the applicant and Mst. Um-e-Farwa.
