Minutes of the Meeting held on 19th March, 2013 chaired by

Hon'ble Chief Justice, Mr. Justice Mushir Alam &

Chairman Security Committee, Hon'ble Mr. Justice Sajjad Ali Shah

A meeting was held in Committee Room to discuss the "Security Measures for Sindh High Court and District Courts of Sindh" under the directions of Hon'ble Chief Justice of Sindh High Court. The Hon'ble Chief Justice, Mr. Justice Mushir Alam chaired the meeting alongwith Hon'ble Mr. Justice Sajjad Ali Shah, Chairman Security Committee. Other following security officers of law-enforcement agencies, SHC-Bar and Sindh High Court Officers attended the meeting.

Following items were discussed during the meeting.

1. SSP Security-I, Mr. Aijaz Hashmi committed with the chair that within the period of 1 week New Police Mobiles shall be provided to the Police for the Security purpose of Hon'ble Judges of SHC.
2. He has further assured the security of newly created ATC Courts and their respective Sessions Judges.

3. SSP South, Nasir Aftab discussed and assured for the three types of Security Measure points for SHC and District Courts **(a) Internal Security (b) External Cordon off (c) Rapid Response Force**. He also assured that he will furnish a comprehensive master security plan (which may be a joint effort of all the stakeholders) within a period of 1 week. Later on the same plan will be discussed with the Learned District & Sessions Judges on any other suitable day. Hon'ble CJ-SHC finally directed the Ld. Registrar to arrange a meeting on 25th Match at 4pm along with all the learned District & Session Judges of Karachi.
4. Col. Ilyas (Wing Commander) of Sindh-Rangers, informed that at present 15 Rangers Personnel are deputed for SHC Security. 2 out of 15 are performing duties on roof-top, however there is need of 4 snipers (sharp shooters) at roof-top.
5. Col Ilyas assured that he will depute 2 additional Rangers Personnel at roof-top in addition with 2 already deputed personnel.
6. It was also directed by the Hon'ble Mr. Justice Sajjad Ali Shah that all the other Security Personnel attached with/for the convoy and security of Hon'ble Judges may be utilized for the Security Purposes during the Court's timing, so that the number of security personnel may be increased.
7. Hon'ble Mr. Justice Sajjad Ali Shah also directed the undersigned to purchase some Walky Talky Sets for the Police Personnel out of the SHC-Budget.
8. SSP Nasir Aftab also suggested for imparting training of Chowkidars and other staff of SHC with the permission of Hon'ble Chief Justice.
9. DSP Zamir Abbasi suggested for the Security Clearance Check of the Police Personnel and Chowkidars deputed at Sindh High Court. For the purpose Hon'ble Chief Justice directed the DSP-Special Branch to provide such a Security Clearance report of all the Chowkidars on urgent basis.

10. DSP Zamir Abbasi also suggested that a Security Wing of SHC-Staff may be created to avoid vulnerable security lapses.
11. DSP Zamir Abbasi further suggested that on initial level Chowkidars of SHC may be directed to wear prominent dress during their duty timings.
12. President Bar Mr. Mustafa Lakhani assured that he will depute 2 Senior Bar Members on Public Gate in order to ensure the Stickers on Advocates' vehicles and other officials' vehicles of Bar. He also ensured to keep the Canteen's Staff away from the premises especially in the night shift. As it was observed that some workers are staying in the Cafeteria's 1st Floor in the night.
13. SP Mohib Ali assured that no vehicle should be parked around the round-about especially on Fridays. He also stated that 4 Traffic Personnel are already deputed at Judges' Entrance Gate and 4 Traffic Personnel are deputed at Public Entrance Side. He further assured the Proper Traffic Controlling at and around the Passport Office, especially in the morning.
14. DSP-Special Branch, Mr. Fateh assured that he will add 4 more Special Branch Personnel for Morning Shift, especially for Public Entrance Gate and Motor Cycle Entrance Gate.
15. Hon'ble Chief Justice further directed to arrange and provide the Security for newly established Anti-Terrorism Courts on early basis.
16. SSP Aijaz stated for the District Courts Security, SSP City court may be called for the next scheduled meeting on 25th Mar 2013.
17. The meeting was ended with a vote of thanks to and by the Hon'ble Chief Justice of Sindh High Court.
